5. MANAGEMENT REPORT

2014 Window Glass Replacement

This year we have had 86 confirmed windows to be replaced in 2014. I have solicited proposals from five different companies. Only Lakeside Glass and G&C Glass submitted proposals. Lakeside Glass was only \$20.00 more per window. Lakeside Glass has been installing the glass windows at Coromandel for the past 10 years and have done a very professional installation and the Coromandel residents have been please with their work.

Window Washing

The spring window washing will begin on Monday, June 9th. They will begin at the 442 Kelburn building and move south from there. If all goes according to schedule the windows should all be washed by June 17th. Please remember to leave your screens unlocked during that time. If the screens are locked they will not come back.

2014/2015 Insurance Renewal

The Board received the insurance renewal from American Family and will approving that renewal of the insurance with them. There is an overall increase of \$1,651.00.

Sprinkler Head Replacements

Several years ago all of the sprinkler heads in all the buildings were supposed to be replaced. There was a recall. The Association was assigned a contractor from Central, manufacturer, to replace all the heads. We discovered that Simplex Grinnell missed about 368 heads. The Board will be approving a proposal to replace these tonight.

The furniture must be stacked and the tarp must be secured so it does not blow off during high winds. These tarps used to cover the outdoor furniture must be removed by May 1st of each year. Susie Chesler seconded the motion. The motion passed unanimously.
- Susie Chesler made a motion to accept the proposal fro United States Alliance Fire Protection, Inc. to replace 268 defective sprinkler heads in the amount of \$16,800.00. Howard Katz seconded the motion. The motion passed unanimously.
- Howard Katz made a motion to accet the proposal from Lakeside Glass to replace 86 window glasses for a cost of \$25,223.81. Susie Chesler seconded the motion passed unimously.
