MANAGEMENT REPORT

1. LANDSCAPING COMMITTEE

At the August landscaping committee meeting it was decided that Charlene Kunkel will now co chair the committee with Mildred Schlifke.

2. FALL CLEAN UP

Brickman Landscaping will be conducting fall clean up from this point forward until the snow flies.

3. SNOW REMOVAL MEETING
