#### **Contract Renewals**

The Board will be renewing contracts with Knox Swan & Dog, Pizzo, Environmental Technology, and Ayala Irrigation. All of these vendors have been working at Coromandel for many years and have not increased their fees for services over all those years. Ayala Irrigation has lowered their labor portion of the contract for start up/winterizing by \$400.00 and the inspections were reduced from \$4000.00 to \$2670.00.

#### **Management Contract**

The Board has interviewed four management companies, Hillcrest, Vanguard, Sierra and Chicagoland. The Board will be approving the contract with Chicagoland at the meeting tonight. Hillcrest, Vanguard and Chicagoland were all very close in their fees and Sierra was double the others.
